This research discusses and provides knowledge to readers about the types and causes of personality disorders. In this case, the researcher takes one of the literary works, that is the comic Deadpool. The purpose of this research is to? (1) what types of personality disorders are found in the main characters in Deadpool comics. (2) what are the causes of personality disorders found in the main character in the Deadpool comic? In this case, the researcher used Theodore Milon's theory as the basis for types of personality disorders and the APA (American Psychological Association) theory for factor that cause personality disorders. This research uses descriptive qualitative research. The data from this study is the character Wade Wilson or Deadpool depicted in comics. The results of this study indicate that Deadpool has four personality disorders: sadistic personality disorder, depressive personality disorder, narcissistic personality disorder, and antisocial personality disorder. The writer found that this study's most dominant personality disorder was sadistic personality disorder. The personality disorder suffered by Deadpool is triggered by psychological and environmental factors.

CHAPTER I INTRODUCTION

A. Background of the Problem

Literature is language which is aestheticized or self-conscious or which foregrounds its own medium (Eagleton:2006). In other words, literature is writing that draws attention to the way it is written, using devices like metaphor, imagery, and wordplay to create a unique and heightened aesthetic experience. Eagleton notes that this definition of literature is not limited to certain genres or forms, but can be found in a wide range of writing, from poetry to novels to essays. He also acknowledges that there are many competing definitions of literature, and that the concept of literature is constantly evolving and changing over time.

According to Pradopo (1994), The environment and human life are depicted through literature. The basic standard used to evaluate literary works is "truth," or whatever the writer wishes to portray. The reader of their literary work will be able to understand the character of the individual in relation to the environment around him or her through that process.

literary works are characterized by their attention to language, form, and meaning. Literary writers, they argue, use language in creative and innovative ways, playing with sound, rhythm, and metaphor to convey complex emotions and ideas. Literary works are also marked by their attention to form, whether it be the sonnet, the novel, or the play, each with its own unique set of conventions and structures. Finally, literary works are concerned with exploring the human condition and engaging with the important questions and issues of the day (Kennedy & Giorgia, 2016).

Comic books are one type of literary works. In comics studies, defining comics has become regular, although it is still a challenging subject to solve. Since the 19th century, comic books have gained popularity. They were once associated with children and the ignorant and were even labeled as "JUNK" (Kunzle, 1973). The literary genre of comics is also described as

Comics are not only a display of text and image interaction or episodic narrative; they are a system driven by a collection of famous images. When verbal and graphical elements are physically recorded in literary studies, comics are referred to be a hybrid word-and-image form. Even if the definitions emphasize various viewpoints, everyone agrees that comics are a seamless combination of visuals and maybe words in order to create storylines. Even while the task of defining comics in comics studies has become commonplace, it is nevertheless a challenging one to resolve. Comic must include graphics but not necessarily text. Pictures are all the emblems, hues, and forms that are different from words in this definition. Picture and text-picture comics are the two types of comics we categorize. Picture comics are narratives that are largely illustrated. However, certain text, such as the story's title and the authors' names, is visible to readers in these comics. Despite the fact that text-picture comics are more widely recognized, picture comics.

Comics are a system driven by a collection of iconic pictures, not just a display of text and image interaction or episodic storytelling. Comics are described as a hybrid word-and-image form in literary studies where verbal and graphical forms are physically documented. We divide comics into two categories: image comics and text-picture comics.

Theodore Millon In his book "*Personality Disorders in Modern Life 2ed*" states that Personality disorders are distinct from normal personality traits in that they are more extreme, inflexible, and maladaptive. They also emphasize that personality disorders are not simply collections of symptoms, but are complex and multifaceted phenomena that reflect underlying psychological processes and early life experiences.

Millon and colleagues propose a dimensional model of personality disorders, which includes four basic dimensions of personality: (1) temperament, (2) self-concept, (3) interpersonal functioning, and (4) defensive style. They argue that personality disorders arise from maladaptive

combinations of these dimensions and that each personality disorder can be understood as a unique configuration of these four factors. The issue also occurs in *Deadpool comics* published by Marvel Comics.

The reason writer chooses the title of this research that, it is important to learn about mental health from an early age. A person with a healthy mentality will also affect their physical condition as well as their quality of life. When a person with a good psychologically, socially and emotionally prosperous, it can be said that the individual has a healthy mentality. And why the writer chooses the Deadpool comic as the subject, is because there are many personality disorders in the Deadpool character.

These comics were the writer's choice for the study's subject since



they contain a lot of contentious subjects. Deadpool recognizes that he is a comic book character, which makes him stand out from other comic book characters. Several times Deadpool describes to his comic readers the tools used when making Deadpool comics. In the comic, Deadpool suffers from one of the symptoms of this mental disorder. Deadpool's mental illness has been a hallmark of the character since 1993 through the comic mini-series *Deadpool: The Circle Chase*.

For example, in the comic *Deadpool Kills the Marvel Universe* was found personality disorder. From

the picture above, it's clearly illustrated for the sadistic when he shoots Spider-man's head. aggressively antagonistic, harsh, dogmatic, and abrasive. prone to irrational wrath fits. Feels good about himself when he dominates, threatens, and degrades other people.

Based on the background, there are a number of reasons why the writer wishes to examine "Deadpool" comics as a subject of research. First off, Deadpool's character contains a variety of personality disorders. Second, Deadpool's capacity for regeneration makes him vulnerable to stress. He has been known to commit suicide merely to know that he may be brought back to life. Due to this, he appears to be mentally unstable and more susceptible to depression. The psychological components of humanity are the primary targets of literary psychology. According to Ratna (2011), and the psychology of literature comprehends these qualities because they are only present and invested in people. The psychology of literature is the study of literature through the prism of psychological activity. The writer will create via creativity, feeling, and labor. They are unable to separate their own psychology from how they are feeling about the work, much as the reader.

A primary character is necessary for a story's storyline to progress. They play a significant part in the tale and have a big impact on what occurs. The primary character must thoroughly communicate the tale while acting out the part. It is connected to psychology.

This suggests a link between the claims made about the psyche in fictional foam and the psych-internalized representational approach. The id, ego, and superego, in Freud's view, make up the three structural elements of a person's personality. Natural roads are found in the desert area of Id. The internalized superego representation of the authority of society's founding fathers and the superego's authoritarian demands are separated by the ego. include instinctual and illogical behavior.

Based on the justification provided, psychology is crucial to the process of examining a literary work from the author's, a character's, or the

work itself's a psychological point of view. In order to create exciting literary works that can be evaluated using the science of psychology, there is an internal struggle, and as a consequence, a new science called "Literary Psychology" is created. A broad category of aberrant personalities known as personality disorders includes people who are thought to have learned, malleable adaptive patterns

of conduct. The research's primary focus is on personality disorders. Characterized by enduring, maladaptive patterns of behavior, cognition, and inner experience that differ from those that are typical in the specific culture, personality disorders are a set of mental illnesses.

A diverse collection of diseases known as personality disorders are characterized by issues in developing a stable sense of self and maintaining strong, healthy relationships. In contrast, it is "inflexible and maladaptive can cause severe functional damage or subjective discomfort," according to Durand and Barlow (2013). We might thus contend that a personality disorder is a distress caused by a person's (character's) long-lasting problems with identity and connections in various aspects of life. Unlike other illnesses, personality disorders begin in childhood and persist into maturity.

But a person with a personality disorder could not experience any subjective pain; instead, it might be others who are impacted by the person's actions. However, the disturbed person's behavior might really cause individuals to feel agony.

C. Types of Personality Disorder

There are fourteen different forms of personality disorders, according to Millon's book, *Personality Disorder in Modern Life 2nd Edition*(2004) : Schizoid, Avoidant, Depressive, Dependent, Histrionic, Narcissist, Antisocial, Sadistic, Compulsive, Negativistic, Masochistic, Paranoid, Schizotypal, and Borderline.

- a) **Schizoid:** Apathetic, indifferent, remote, solitary. Neither desires nor need human attachments. Minimal awareness of feelings of self or others. Few drives or ambitions, if any.
- b) **Avoidant:** Hesitant, self-conscious, embarrassed, anxious. Tense in social situations due to fear of rejection. Plagued by constant performance anxiety. Sees self as inept, inferior, or unappealing. Feels alone and empty.

- f) **Narcissist:** Egotistical, arrogant, grandiose, insouciant. Preoccupied with fantasies of success, beauty, or achievement. Sees self as admirable and superior, and therefore entitled to special treatment.
- g) **Antisocial:** Impulsive, irresponsible, deviant, unruly. Acts without due consideration. Meets social obligations only when self-serving. Disrespects societal customs, rules, and standards. Sees self as free and independent.
- h) **Sadistic:** Explosively hostile, abrasive, cruel, dogmatic. Liable to sudden outbursts of rage. Feels self-satisfied through dominating, intimidating and humiling others. Is opinionated and closeminded.
- i) **Compulsive:** Restrained, conscientious, respectful, rigid. Maintains a rule- bound lifestyle. Adheres closely to social conventions. Sees the world in terms of regulations and hierarchies. Sees self as devoted, reliable, efficient, and productive.
- j) **Negativistic:** Resentful, contrary, sceptical, discontented. Resist fulfilling other's expectations. Deliberately inefficient. Vents anger indirectly by undermining other's goals. Alternately moody and irritable, then sullen and withdrawn.
- k) **Masochistic:** Deferential, pleasure-phobic, servile, blameful, self-effacing. Encourages others to take advantage. Deliberately defeats own achievements. Seeks condemning or mistreat partners.

- n) **Borderline:** Unpredictable, manipulative, unstable. Frantically fears abandonment and isolation. Experiences rapidly fluctuating moods. Shifts rapidly between loving and hating. Sees self and others alternatively as all-good and all-bad.

D. Causes of Personality Disorder

Based on what the writer found at American Psychological Association (APA), there are five causes of personality disorder. The American Psychological Association, which has over 133,000 members and includes researchers, teachers, clinicians, consultants, and students, is the biggest scientific and professional association of psychologists in the country. There are 54 division interest groups covering various thematic or subspecialty areas of psychology.

- a) **Genetics.** Some potential hereditary characteristics for personality disorders are starting to emerge, according to researchers. For instance, one team has discovered a gene that isn't working properly that may contribute to obsessive-compulsive disorder. Other studies are looking at the genetics of aggressive, anxious, and fearful characteristics that may contribute to personality disorders.
- b) **Childhood trauma.** Results from the Collaborative Longitudinal Personality Disorder Study, one of the biggest studies of personality disorders, provide information regarding the significance of early life events. According to one study, the quantity and kind of early traumas are

- c) **Verbal abuse.** Even abusive language can have an effect. Researchers questioned women whether they had yelled at their kids, told them they didn't love them, or threatened to send them away in a study involving 793 moms and kids. Children who had suffered such verbal abuse had a threefold increased risk of developing borderline, narcissistic, obsessive-compulsive, or paranoid personality disorders as adults compared to other children.
- d) **High Reactivity.** It's possible that sensitivity to light, noise, texture, and other stimuli also has an impact. Children that are too sensitive and have what psychologists refer to as "high reactivity" are more likely to become timid, shy, or nervous adults. High reactivity's function is still not entirely apparent, though. Only 10% of infants who are very reactive as newborns grow on to acquire social phobias.
- e) **Peers.** Certain elements can aid in preventing personality problems in youngsters. According to psychologists, even one close contact with a parent, teacher, or friend can counteract harmful impacts.

Based on what the writer found at American Psychological Association (APA), there are five causes of personality disorder. Researchers claim that certain possible inherited traits for personality disorders are beginning to appear. One team, for instance, has identified a gene that isn't functioning correctly and may be a factor in obsessive-compulsive disorder. According to one study, the occurrence of personality disorders is correlated with the number and kind of childhood traumas. For instance, borderline personality disorder sufferers had a disproportionately high rate of childhood sexual abuse. Even verbal abuse has consequences. Such verbal abuse increased the risk of compared to other childhood events, borderline, narcissistic, obsessive-compulsive, or paranoid personality disorders are three times more

common in adults. Sensitivity to light, noise, texture, and other stimuli could also have an effect. Only 10% of babies who are highly reactive as infants go on to develop social phobias. Certain elements can aid in preventing personality disorders in children. Psychologists claim that even just one close interaction with a parent, teacher, or friend may offset negative impacts.

E. Previous Studies

The writer of this study is the first scholar at The State Islamic University of Sultan Thaha Saifuddin Jambi's English Literature Department to examine personality disorders in the Marvel Comics' Deadpool series. The writer provided some earlier research on personality disorders.

The first study is written by Fiona Asmara (2019) University of Muhammadiyah Sumatera Utara Medan. The research entitled “*An Analysis of Multiple Personality Disorder of Characterization in Split Movie*”. In this study, the psychological conflict and many personality traits of the main character in the movie *Split* were analyzed. The analysis's findings indicate that twenty-seven were applied to the major characters in the movie *Split*. The *Split* movie's main protagonists' psychological turmoil was represented in two different ways: Nothing was outside. And internal divided thinking 3, feeling 3, sensing 3, intuiting 3. There were two types of personalities in the *Split* movie, they were Extrovert 4, and Introvert divided Trauma 3, Anxiety 5 and Depression 3.

The second previous research is an article by Riski Andrian Ramadhana, Department of English, Faculty of Cultural Studies, University of Sumatera Utara. The research entitled “*The Analysis of Personality Disorder on Two Characters in the Animation Series Black Rock Shooter*” aims to find out personality disorder that portrayed by the two characters, Kagaria and Yomi in *Black Rock Shooter*. Personality disorder theory by Duran & Barlow was used to analyze this research. The results of this study demonstrated how human needs are related to the emergence of personality disorders. Unmet needs can lead to personality disorders.

According to the findings of this study, Robert has eleven other personalities and has had multiple personality disorders for decades. He has also destroyed his life and suffered from depression, mood swings, alcoholism, amnesia, suicidal thoughts, and bulimia as a result of his multiple personality disorder.

The fourth research is written by Cristina Meida Rosanti (2006), Sanata Dharma University. The title is “*Personality Disorder Revealed in Catherine’s Character in Ernest Hemingway’s Garden of Eden*”. In order to gather sources, the writer employed both library research and Abrams' theory. A psychological method is used in this investigation. According to the findings of this research, Catherine is characterized as having certain typical traits. She was lovely and sweet. Sadly, she has unstable emotional behavior. She is envious of others. Even jealousy is a normal, human feeling that controls the majority of humanity. It causes the human psyche to act on jealous emotions, which can cause trouble and even catastrophe.

The fifth research is written by Andrie Widiyanto (2006), Sanata Dharma University, Faculty of Letters, Department Of English Letters. The research entitled “*Antisocial Personality Disorder of the Main Character In Thomas Harris’s Hannibal*”. focuses on this study to discuss further Hannibal Lecter. There are two problems in this thesis. The first problem is aimed at finding out the description of the character, Hannibal Lecter. The second problem is aimed at identifying Hannibal Lecter’s antisocial personality disorder based on psychological theories. The result of this thesis is that Hannibal Lecter has a psychological disorder. He cannot accept what happened in his childhood

And the last previous study are written by Abdurrahman (2020), Islamic State University of Sulthan Thaha Saifuddin Jambi, Faculty of Adab and Humanities, Department of English Literature. The thesis is entitled "*Personality Disorder as seen in Joker Movie by Todd Phillip*". Descriptive qualitative research is used in this study. A guy in the movie Joker and other sources relevant to issue formulation are the source of data for this study. According to the study's findings, Arthur suffers from a number of personality problems. Borderline personality disorder, depressed personality disorder, sadistic personality disorder, antisocial personality disorder, and negativistic personality disorder are the five types of personality disorders Arthur has. Character Arthur suffers from a personality disorder that is brought on by psychological and environmental factors.

Based on the earlier study mentioned, the writer used Theodore Millon's theory and concentrated on how the personality disorder in the main character of the Deadpool comics was reflected. The writer concentrated on identifying the types of personality disorders reflected in the main character in order to differentiate this research from previous studies. and to analyse what causes the personality disorder of the main character in Deadpool Comics using the American Psychological Association (APA)'s concept and psychological approach. Furthermore, this research used a different object which is Comics.

CHAPTER III METHOD OF RESEARCH

A. Design of Research

The descriptive qualitative method is the one employed by the writer in this study. Descriptive qualitative research is used in this study. The research's data came from a man in the Deadpool comics and other problem-solving-related sources. Using Theodore Millon's theory, data from Wade Wilson, or Deadpool attitude's behaviors, and events were evaluated.

Both posing questions and offering solutions are important components of qualitative research and analysis. As a result, one method of analytical bridging is to pose questions that speak to concepts that are present in, or indicated by, two or more viewpoints. With the help of the questions, qualitative researchers can concentrate on parts of the viewpoints that may, at the very least, be compatible.

While the qualitative methodology aims to dig deeper into an existing phenomenon, words, phrases, clauses, and sentences that are uttered. According to Djajasudarma (2006), “A qualitative approach is a process that produces descriptive data in spoken or written form in a certain community”. She also says, “The data collected is not numbers, it can be in the form of words or a description of something” (Djajasudarma, 2006).

The descriptive method can be understood as problem-solving if it uses an image to examine the subject or research object or if it describes the subject or research object (novel, drama, short story, poetry) as it is at the moment based on clear facts or unification. In other words, the descriptive approach is a methodology for addressing problems that involves describing the state of the item or topic being studied.

By carefully describing a situation, an issue, or phenomena, providing information about the standard of living in a community, or conveying one

Formerly classified as a mental ailment, a sadistic personality disorder is now more commonly seen as a way of life, a personality quirk, or a feature. In the comic "*Deadpool Kills the Marvel Universe*", The members of x man

aim to cure Deadpool to become a normal person by taking him to a doctor named Benjamin Brighton.

b. Antisocial Personality Disorder

Treatment of the antisocial group might be difficult. They frequently attend treatment against their will and as a punishment for social sins. Age tends to improve the likelihood of therapeutic progress, but generally, antisocial people view therapy as a game where the object is to deceive and outdo the therapist by acting sorry and repentant but eventually reverting to their old habits. (Theodore Millon:2004).

Antisocial people may feel extreme fear at the prospect of being dominated by people or events, dread revenge from those they have hurt, or dread, for example, an inevitable jail sentence. Therefore, increases in prolonged acting-out behavior are likely to indicate a long-lasting life predicament or an external restraint that cannot be rapidly removed by impulsive physical action. An antisocial personality disorder sufferer could come across as pleasant and captivating. They are also impulsive, aggressive, abusive, and egotistical. Additionally, they do not care about right or wrong and do not mind taking risks.

c. Depressive Personality Disorder

Depressive personality disorder (Kernberg, 1992), The highest-level expression of the disease of depressed affect and that of sadomasochism also reveals an excessively punishing internal value system in addition to a well-integrated superego (as do all other personalities with neurotic personality structure). As a result, the patient is more likely to engage in self-defeating conduct. This is because the patient has an unconscious desire to suffer in order to atone for guilt emotions or as a condition for enjoying sexual pleasure. A depressive mood is more prone to strike the depressive-masochistic personality.

2. The Causes of Personality Disorder as Reflected to the main character in Deadpool Comics

After knowing the types of personality disorders reflected to the main character as seen in *Deadpool* Comics, now the writer found two causes of personality reflected to the main character as seen in *Deadpool* Comics. They are psychological factors and environmental factors.

a. Psychological factor

According to Widiger and Mullins-Sweatt (2009), one of the key psychological factors that contribute to personality disorders is early childhood experiences, particularly those involving attachment and parental bonding. Children who experience neglect, abuse, or inconsistent parenting are more likely to develop personality disorders later in life. Additionally, genetic factors may play a role in the development of personality disorders, as certain traits and temperaments may be inherited. Other psychological factors that may contribute to personality disorders include cognitive distortions and maladaptive coping strategies. Individuals with personality disorders may have negative beliefs about themselves, others, and the world around them, which can lead to distorted thinking and problematic behaviors. They may also use maladaptive coping strategies such as substance abuse, self-harm, or other forms of self-destructive behavior to deal with stress and emotional distress.

Overall, the psychological factors that contribute to personality disorders are complex and multifaceted, and they require a comprehensive and integrated approach to diagnosis and treatment. Widiger and Mullins-Sweatt's book provides a useful guide to understanding these factors and developing effective interventions for individuals with personality disorders.

Psychological factors are a person's psychological state, which may have an effect on how they behave, think, and interact with others. Initial psychological causes of personality disorders include trauma, particularly the trauma of psychological or sexual abuse over a prolonged period of infancy. The personality

For instance, the prevalence of childhood sexual trauma was notably high in individuals with borderline personality disorder.

A person who repeatedly encounters these things will undoubtedly remember them and eventually develop many personas as a result of the trauma they suffered.

b. Environmental factor

According to the book "Handbook of Personality Disorders: Theory, Research, and Treatment" edited by W. John Livesley, Roseann Larstone, and Mark F. Lenzenweger (2018), environmental factors are a key component of the bio-psycho-social model of personality disorders. This model emphasizes the importance of environmental influences in the development of personality disorders, alongside biological and psychological factors.

The book discusses a variety of environmental factors that may contribute to the development of personality disorders. For example, family environment is an important environmental factor that has been linked to the development of personality disorders, particularly borderline and narcissistic personality disorders. A history of abuse, neglect, or inconsistent parenting can lead to problems with attachment, emotional regulation, and interpersonal functioning, which may in turn contribute to the development of personality disorders.

Psychological health is influenced by environmental and psychosocial factors. Included are problems with the person's family or primary support system, such as a relative's passing, a divorce or separation due to mental illness, sexual or psychological abuse, interfamily conflict, or inefficient or incorrect discipline at home. Outside of the family, social environment issues are also discussed.

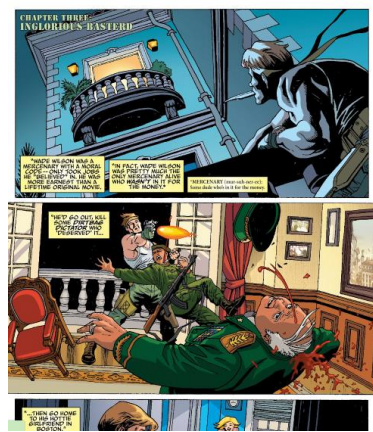

CHAPTER V

APPENDIX 1

Biography of the writers on the comics

1. Fabian Nicieza



Fabian Nicieza born December 31st, 1961, is an Argentine-American comic book writer and editor who is best known for his work on Marvel titles such as X-Men, X-Force, New Warriors, Nomad, Cable, Deadpool and Thunderbolts, for all of which he helped create numerous characters, among them Deadpool, Domino, Shatterstar, and Silhouette.

Nicieza was born in Buenos Aires, Argentina, the son of Omar and Irma Riguetti Nicieza. He was four years old when his family moved to the United States. Growing up in New Jersey, Nicieza learned to read and write from comic books. He lived first in Sayreville, New Jersey and moved to Old Bridge Township, where he attended Madison Central High School, from which he graduated in 1979. He studied at Rutgers University, interning at the ABC television network before graduating in 1983 with a degree in advertising and public relations. His brother is Mariano Nicieza, also a comic book writer and editor.

In 1985, Nicieza joined the staff at Marvel Comics, initially as a manufacturing assistant, later moving to the promotions department as an

advertising manager. During this period he began to take his first freelance work for Marvel, writing short articles for Marvel's promotional magazine *Marvel Age*.

Nicieza's first published comics story came with *Psi-Force No. 9* (July 1987), a title in Marvel's short-lived New Universe imprint. This led to his becoming that title's regular writer from #16 (Feb. 1988) until #32 (June 1989), the final issue. This led to fill-in work on titles such as *Classic X-Men*, for which he provided backup stories, and in the *Marvel Annuals'* 1989 summer crossover "Atlantis Attacks". After Tom DeFalco, then Marvel's editor-in-chief, created the superhero team the *New Warriors*, using existing characters, in *Thor No. 412* (Dec. 1989), he selected Nicieza to write the spin-off series. Nicieza recalled "I took the assignment for two reasons. First, I saw a lot of potential in these characters that had already been deemed useless. And secondly, I really wanted to write a monthly book." Collaborating with pencilers Mark Bagley and later Darick Robertson, primarily, Nicieza went on to write the title for most of its first 53 issues (July 1990 – November 1994). Years later, Nicieza said that he considers the first 25 issues of *New Warriors* to be the best work of his career.²³

2. Duane Louis Swierczynski



Duane Louis Swierczynski (born February 22, 1972) is an American crime writer known for his work in non-fiction books, novels and comic books. Duane Swierczynski was born and raised in Frankford, a neighborhood in lower Northeast Philadelphia, Pennsylvania, United States. After leaving in the late 1990s and making several stops elsewhere, he moved to another neighborhood in Northeast Philadelphia from 2002 until 2016. He currently resides with his family in the Los Angeles area. Swierczynski's surname loosely translates as "dweller near a fir tree." He and his brother Gregg were named after the Allman Brothers.

Swierczynski has written six non-fiction books, including *This Here's A Stick-Up: The Big Bad Book Of American Bank Robbery* (Alpha, 2002) and *The Big Book O' Beer* (Quirk, 2004). He has worked as an editor at *Men's Health* and *Details* as well as Philadelphia magazines including the *Philadelphia City Paper*, which he left in February 2008. *Secret Dead Men*, Swierczynski's crime fiction debut, was published in 2005 by PointBlank and has since written nine further novels. His fiction draws heavily on crime noir themes, making frequent use of femmes fatale.

In 2008, Swierczynski signed an exclusive deal with Marvel Comics, where he penned *Moon Knight Annual #1*, a *Punisher* one-shot ("Force of Nature"), and the second volume of *Cable*, which lasted 24 issues. He also

assumed writing duties on The Immortal Iron Fist from issue #18 until the title's cancellation. His other planned projects with Marvel included a revival of Werewolf By Night, a story starring Bishop, and contributing to the X-Men-related event Messiah War. He later wrote the 2012 rebooted Bloodshot series from Valiant Comics and the Black Hood series from Archie Comics beginning in 2015.

Lion's Gate Entertainment picked up Swierczynski's novel Severance Package for film treatment and hired Brett Simon to direct the film and co-write the script with Swierczynski. Swierczynski is known for using a variety of social media tools, including Twitter and Blogspot. In September 2011, DC Comics relaunched Birds of Prey with issue #1 as part of their The New 52 publishing initiative. Swierczynski replaced Marc Andreyko as the writer, with Jesus Saiz handling the art. Batgirl and Poison Ivy will later be joining the team.²⁴

3. Cullen Bunn



Cullen Bunn is an American comics writer, novelist, and short story writer, best known for his work on comic books such as Uncanny X-Men, X-Men:

Blue, Magneto and various Deadpool miniseries for Marvel Comics, and his creator-owned series The Damned and The Sixth Gun for Oni Press and Harrow County for Dark Horse Comics, as well as his middle reader horror novel Crooked Hills, and his short story work collection Creeping Stones & Other Stories. As of 2018, Bunn writes X-Men: Blue and Venomized for Marvel, Pumpkin Head for Dynamite, Subspecies for Action Lab, Shadow Roads for Oni Press, Regression for Image, Unholy Grail, Brothers Dracul and Dark Ark for Aftershock Comics, and Harrow County for Dark Horse

Cullen Bunn grew up in rural North Carolina. He lived there until he was 19, when his parents moved to Thayer, Missouri to run a cattle farm. After a couple years, his parents moved back to North Carolina, but Bunn remained in Missouri. He attended Missouri State University.

Bunn's noir/horror comic, and first collaboration with Brian Hurtt, The Damned, was published in 2007 by Oni Press. The sequel, The Damned: Prodigal Sons, was released in 2008. In 2010 Oni Press premiered Bunn's series, The Sixth Gun, which ran from May 2010 to June 2016. In 2011, Oni Press published Bunn's original hardcover graphic novel, The Tooth. That same year, Earwig Press/Evileye Books published Bunn's middle-reader horror prose series Crooked Hills. He also was one of the writers in Marvel Comics' crossover storyline that year, "Fear Itself". He wrote the tie-in book Fear Itself: The Black Widow, which received mostly positive reviews, and later wrote two issues of The Fearless, a spinoff published after the conclusion of "Fear Itself" that also received positive reviews. In November of that year, Lion Forge Comics published Bunn's digital comic, Night Trap. In 2013 Bunn wrote Deadpool Kills Deadpool for Marvel, which received positive reviews. In December 2013, Marvel announced the then-new ongoing Magneto, a series following the solo adventures of Magneto and penned by Bunn, with art by Gabriel Hernández Walta. The series debuted in March 2014 and ran for 21 issues, ending in August 2015. Bunn's Harrow County, an ongoing creator-owned horror series with art by Tyler Crook, published by Dark Horse Comics, was announced in San Diego Comic-Con 2014. The first

Issue debuted in May 2015 and sold out a distributor level, with a second printing commissioned by Dark Horse.

In September 2014, Bunn's six-issue limited series *Wolf Moon*, with art by Jeremy Haun and covers by Jae Lee, was announced as the newest miniseries from Vertigo. The series, which sought to re-imagine the werewolf mythos, was released in December 2014. After Brian Wood, Bunn was announced as the new writer of *Moon Knight* for Marvel, teaming up with artist Ron Ackins for a five-issue run beginning with issue #13 in March 2015.²⁵

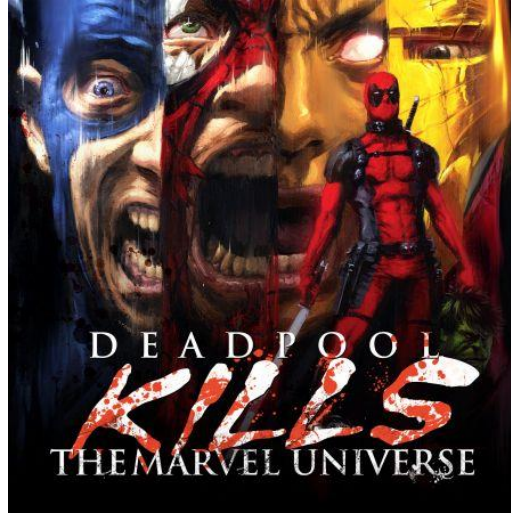

2. X-Men Origins: Deadpool

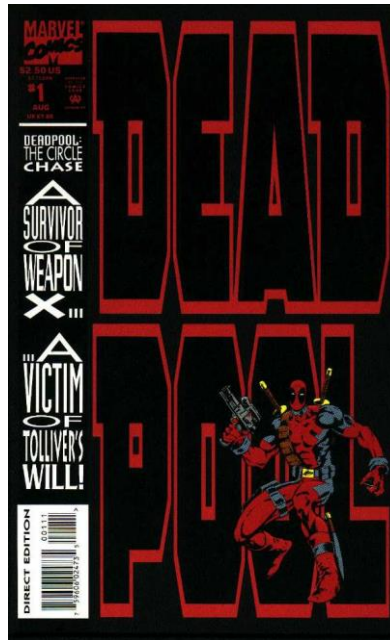

Black Tom goes to Mr. Gezdbadah and asks him about the will.

In New Jersey, Sluggo greets Mrs. Carlysle at her home. He asks her if she has heard from her daughter, Vanessa recently. She tells him no and he apologizes and then turns to leave. Then, a noose wraps around his neck and lifts him off the ground. Vanessa is on the roof of her mothers home and tells Sluggo that he is going to pay for what he did when he killed her friend Tina. He tells her that Deadpool has been looking for her. She then grabs him and throws him through

her mother's window and tells her to call the police. She then takes off to go find Tolliver's will and be rich and happy.

Meanwhile, Courier meets with a man named Mr. Bashur. Bashur asks what his assignment is and Courier says that he has an order from the Executive Elite to take out a hit on Deadpool, Copycat, and Cable for the death of Nyko's brother Pico. The fee for doing this is information that will give Mr. Bashur a good advantage in finding Tolliver's will. Bashur tells Courier that he has a deal and that Deadpool had better say his prayers as he is first on the list.

In Cairo airport, Black Tom and Juggernaut board a plane to leave Cairo to go to Dublin. Deadpool calls Weasel from the airport and Weasel tells him the flight that Tom and Juggernaut are leaving on and then says it is leaving right then. Deadpool races out on the tarmac as the plane is about to fly. He jumps on the wheel and climbs in the plane as it starts its ascent. Black Tom is about to order a bloody Mary as Deadpool blasts through the plane's floor. He hits the briefcase in the overhead luggage and they all go after it. Deadpool then throws grenades at the planes door since Tom is standing in front of it and it blows open and sucks Tom out. Juggernaut goes jumping out after him. Deadpool closes the door and then gets the disc with all the information on it. He then turns to everyone and tells them to order drinks and that the plane is officially hijacked.

In Maine, Weapon X returns home. He gets off the boat and walks inside. He is greeted by Slayback. Slayback grabs his throat and tells him that he is looking for Deadpool. He says that he wants to know and he will let Kane live if he tells him. He also says that he has waited ten years to come "back from the dead" and he wants to see Deadpool dead and he wants to be the one to do it.²⁷


