CHAPTER I

INTRODUCTION

A. Background of the Problem

Semiotics etymologically comes from the Greek word Semeion which means sign. Signs can be interpreted as based on social conventions that have previously been built. Initially the sign was interpreted as something that could refer to something else. Semiotics can also be identified as a science that studies events, objects that are around, or culture that exists as a sign. In a semiotic sense, signs take the form of words, images, sounds, gestures and objects. In contemporary semiotics, that section studies signs that are not isolated but as part of a sign-semiotic system (such as media or genre). Study how meaning is made and how reality is represented (Indiawan in Mersita, 2022).

Semiotics is an action, influence, or cooperation of three subjects, including sign, object and interpretation. As for what is meant by the subject is a semiotic entity that is abstract in nature, not influenced by concrete communication habits. Sign is a liaison between something and the results of interpretation. Express something else in some way. The result of this interpretation is a psychological event in the mind of the interpreter (Asriningsari & Umaya, 2015).

Criticism is the overall term for studies concerned with defining, classifying, analyzing, interpreting, and evaluating works of literature (Rao,

medium for social criticism in presenting a portrait of reality (Alfathoni,

conveyed can be in the form of ideas, points of view, different perspectives

Socio-politic criticism comes from the existence of a politic process in the form of policies, decisions, or steps (outputs) implemented by the government or authorities, which have an impact on the order of social reality and the life of the nation. To stimulate every community to respond, provide input in the form of input, as well as social criticism. In a way, socio-politic criticism turns into a tool for disseminating fresh ideas and evaluating established ones in the service of social change. Film is one media where social critique as a response and input from the community has been expressed, particularly in response to social and politic challenges (Rizaldi, 2019).

The Hunger Games film received positive reviews from film critics and was a box office success with revenues of US\$694.4 million from a production budget of only US\$78 million (Rofik, 2017).

The decision to pick this particular scenario was made because, in the Hunger Games movie, there is a pronounced socioeconomic class divide between a district and Panem's capitol, in addition to the government's hegemonic rule over the nation. The analysis of this film is important to see the gap between classes so that good solutions can be found so that life can be more just and prosperous without inequality. This case can have broad implications for the life of the state, for example if a country has a state system like in the *Hunger Games* film, then it is undeniable that there was many uprisings because the government has failed to implement the proper state system, they does not carry out the principle of justice to the people it leads.
